The Department of Chemistry in the College of Arts and Sciences invites applications for part-time positions at the rank of Adjunct, teaching one or two courses per semester, and also full-time Lecturer, teaching four courses per semester. Qualified applicants will have a PhD and postdoctoral or equivalent experience, with a demonstrated track-record of excellence in teaching. Candidates committed to working with underrepresented minorities in STEM and non-STEM disciplines are strongly encouraged to apply.
